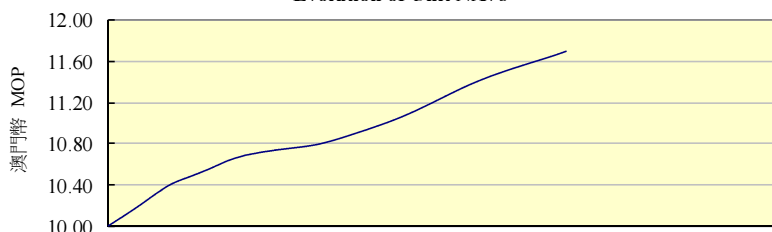

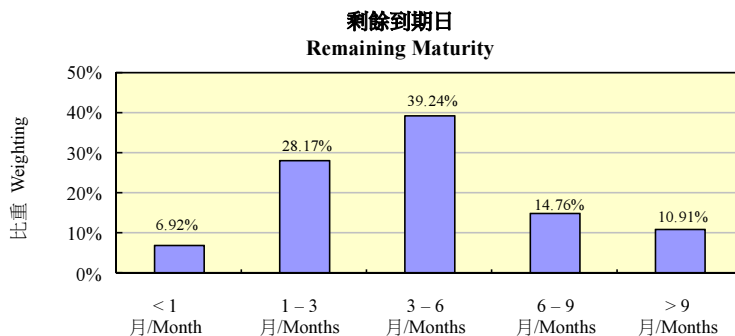

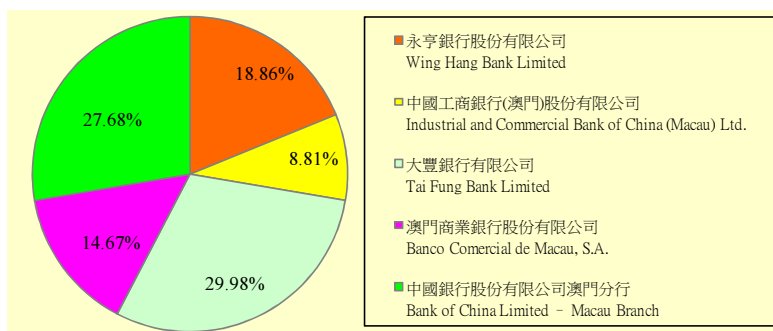
出資單位淨值變動
