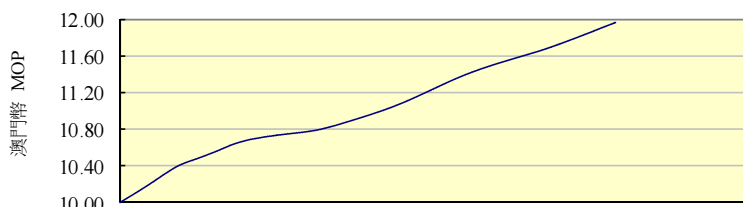

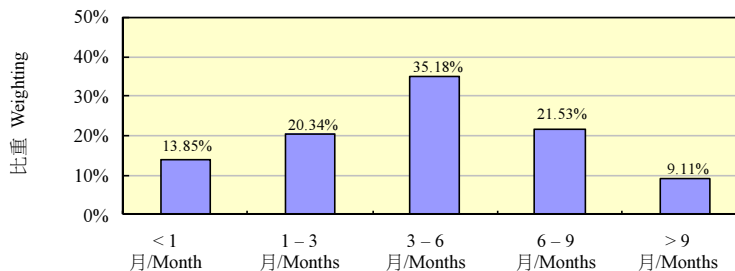

出資單位淨值變動 Evolution of Unit NAVs

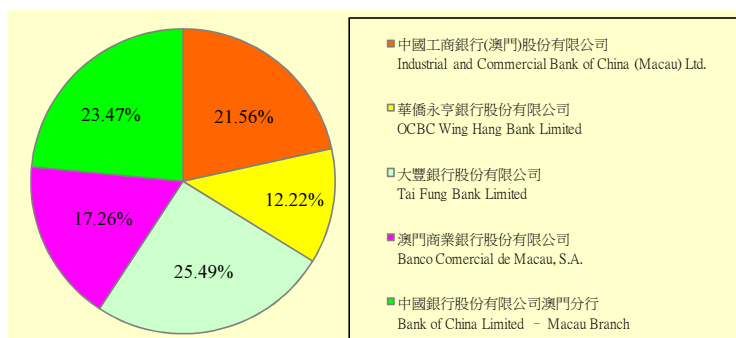


存款到期日分佈 Distribution of Deposits by Maturity
